

CONTRIBUTOR INFORMATION

Content: *The Journal of Media Economics* publishes original research on the economics and policy of mediated communication, focusing on firms, markets, and institutions. Reflecting the increasing diversity of analytical approaches employed in economics and recognizing that policies promoting social and political objectives may have significant economic impacts on media, the *Journal of Media Economics* encourages submissions reflecting the insights of diverse disciplinary perspectives and research methodologies, both empirical and theoretical.

Manuscript Submission: Only articles written in English will be considered. Prepare your manuscript with Microsoft Word or another popular word-processing program and send it as a file attachment by e-mail to Dr. Steven S. Wildman at swildman@msu.edu and copy Joy Mulvaney with the message and attachment at mulvaney@msu.edu. Authors who prefer hard copy submission should mail four printouts of their manuscript to Dr. Steven S. Wildman, *Journal of Media Economics*, Quello Center for Telecommunication Management and Law, 409 Communication Arts & Sciences Building, Michigan State University, East Lansing, MI 48824-1212. Prepare manuscripts according to the *Publication Manual of the American Psychological Association* (5th ed., 1994). Use 8½× 11-in. nonsmear paper (if possible). Set all margins at 1½ in. Print text using 10-point (12-pitch) Courier or any other typeface that results in 67 to 69 characters per line (counting spaces) and 27 to 29 lines per page. (In short, print 1,800 to 2,000 characters per page.) Type all components of the manuscript double-spaced, including title page, abstract, text, quotes, acknowledgments, references, appendixes, tables, figure captions, and footnotes. An abstract of 75 words should be typed on a separate page. Manuscripts should be limited to a maximum of 25 pages including references, tables, and figures. Authors must use nonsexist language in their articles as specified in the "Guidelines to Reduce Bias in Language," which appears on pages 46 to 60 of the *APA Manual*. Four photocopies of the illustrations and the original illustrations should accompany the manuscript. All manuscripts submitted will be acknowledged promptly. Authors should keep a copy of their manuscripts to guard against loss.

Blind Review: To facilitate anonymous review, only the article title should appear on the first page of the manuscript. An attached cover page must contain the title; authorship; authors' affiliations; any statements of credit or research support; and mailing addresses, phone numbers, and fax numbers of the authors. Every effort should be made by the authors to see that the manuscript itself contains no clues to their identities.

Permissions: Authors are responsible for all statements made in their work and for obtaining permission from copyright owners to reprint or adapt a table or figure or to reprint a quotation of 500 words or more. Authors should write to original author(s) and publisher to request nonexclusive world rights in all languages to use the material in the article and in future editions. Provide copies of all permissions and credit lines obtained.

Regulations: In a cover letter, authors should state that the findings reported in the manuscript are original and have not been published previously and that the manuscript is not being simultaneously submitted elsewhere. Authors should also state that they have complied with American Psychological Association ethical standards in the treatment of their samples.

Production Notes: After a manuscript is accepted for publication, its author is asked to provide a computer disk containing the manuscript file. Files are copyedited and typeset into page proofs. Authors read proofs to correct errors and answer editors' queries. Authors may order reprints of their articles only when they return page proofs.
