

## INSTRUCTIONS TO AUTHORS

**Aims and Scope.** Dedicated to the presentation of essential aspects of drug and alcohol abuse by established workers in their respective fields, *The American Journal of Drug and Alcohol Abuse* provides a medically oriented forum for interchange of ideas between preclinical, clinical, and social modalities involved in the study and treatment of drug abuse and alcoholism.

Address manuscript submissions to the Editor, Dr. Thomas Kosten, at [ajdaa-editor@bcm.edu](mailto:ajdaa-editor@bcm.edu). The files should be prepared using MS Word or WordPerfect and should be 1500-2000 words in length, containing no more than 20-25 references and two tables. Each manuscript must be accompanied by a statement that it has not been published elsewhere and that it has not been submitted simultaneously for publication elsewhere. Authors are responsible for obtaining permission to reproduce copyrighted material from other sources and are required to sign an agreement for the transfer of copyright to the publisher. All accepted manuscripts, artwork, and photographs become the property of the publisher.

All parts of the manuscript should be double-spaced, with margins of at least one inch on all sides. Number manuscript pages consecutively throughout the paper. Authors should also supply a shortened version of the title suitable for the running head, not exceeding 50 character spaces and several keywords. Each article should be summarized in an abstract of not more than 100 words. Avoid abbreviations, diagrams, and reference to the text in the abstract.

**References.** References to cited literature should be identified by a numbered list at the end of the paper in order of appearance. Please cite in text with the number in parentheses. Examples: *Journal*: Chung T, Langenbucher J, Labouvie E, Pandina RJ, Moos RH. Changes in alcoholic patients' coping responses predict 12-month treatment outcomes. *J Consult Clin Psychol* 2001; 69(1):92-100. *Book*: Monti PM, Abrams DB, Kadden RM, Cooney NL. *Treating Alcohol Dependence: A Coping Skills Training Guide*. New York, NY: Guilford Press, 1989. *Contribution to a Book*: Pantalon MV, Schottenfeld RS, Monitoring therapist and patient behavior during behavioral interventions of illicit drug abuse: process research perspectives. In *Contingency Management Interventions for Illicit Drug Abuse*. Higgins S, Silverman K, eds. Washington, DC: American Psychological Association Books, 1999; 309-325.

**Illustrations.** Illustrations submitted (line drawings, halftones, photos, photomicrographs, etc.) should be clean originals or digital files. Digital files are recommended for highest quality reproduction and should follow these guidelines:

- 300 dpi or higher
- Sized to fit on journal page
- EPS, TIFF, or PSD format only
- Submitted as separate files, not embedded in text files

Color illustrations will be considered for publication; however, the author will be required to bear the full cost involved in their printing and publication. The charge for the first page with color is \$900.00. The next three pages with color are \$450.00 each. A custom quote will be provided for color art totaling more than 4 journal pages. Good-quality color prints should be provided in their final size. The publisher has the right to refuse publication of color prints deemed unacceptable.

**Tables and Figures.** Tables and figures (illustrations) should not be embedded in the text, but should be included as separate files. A short descriptive title should appear above each table with a clear legend and any footnotes suitably identified below. All units must be included. Figures should be completely labeled, taking into account necessary size reduction. Captions should be typed, double-spaced, on a separate sheet. All original figures should be clearly marked in pencil on the reverse side with the number, author's name, and top edge indicated.

**Proofs.** Page proofs are sent to the designated corresponding author. They must be carefully checked and returned within 48 hours of receipt. Please note that in the proof stage, only typographical errors, printer's errors and errors of scientific fact can be corrected. No substantial author's changes will be made.

**Offprints/Reprints.** Each corresponding author of the article will receive a complete copy of the issue in which the article appears. Reprints of an individual article are available for order at the time authors review page proofs.
