

Instructions for authors

****Note to Authors: please make sure your contact information is clearly stated in all files and all correspondence with the Editors and the Publisher.****

Articles will be considered for publication by the Editors on the understanding that the articles have not previously been published and are not under consideration elsewhere. All manuscripts will be refereed prior to publication.

Form of manuscript All contributions must be submitted by e-mail, written in Word. Articles should be kept within 8000 words, double-spaced pages, inclusive of footnotes. Page 1 should contain the article title, the name(s) and affiliation(s) of the author(s), and the name and the complete mailing address of the person to whom correspondence should be sent. The manuscripts must include an abstract of about 150 words.

Tables and figures All tabular material should be numbered in order of appearance with Arabic numerals. The titles should be typed above, and the sources and (eventual) footnotes below the tables. All artwork and maps should be numbered in order of appearance with Arabic numerals. The titles and sources should be typed as tables. All artwork and maps should be submitted as separate files in JPEG or TIFF.

Footnotes and references Footnotes to the text should be indicated by superscript Arabic numerals in running order throughout the article. The first reference to a source should fully cite its author and title, as in the examples below. Subsequent citations should give the author's surname and an abbreviated form of the title.
