

Submitted manuscripts should be arranged according to the rules stated in 'Uniform requirements for manuscripts submitted to biomedical journals' *Ann Intern Med* 1997; 126: 36–47, or *JAMA* 1997; 277: 927–34. The full document is available at www.icmje.org

When submitting a paper, the author should always make a full statement to the editor about all submissions and previous reports that might be regarded as redundant or duplicate publication of the same or very similar work.

Conflict of interest and funding: Authors are responsible for recognising and disclosing financial and other conflicts of interest that might bias their work. They should acknowledge in the manuscript all financial support for the work and other financial or personal connections to the work.

Statistic validity: If statistical data are provided the authors are requested to submit an official statement issued by a certified statistician (with a proper affiliation) regarding the validity of methods used.

Ethics and consent: When reporting experiments on human subjects, indicate whether the procedures followed were in accordance with the ethical standards of the responsible committee on human experimentation and with the Helsinki Declaration of 1975, as revised in 1983. Do not use patients' names, initials, or hospital numbers, especially in illustrative material. Papers including animal experiments or clinical trials must be accompanied by an approval by the local ethics committee. Please give date of issue and registration number.

Identifying information should not be published in written descriptions, photographs, and pedigrees unless the information is essential for scientific purposes and the patient (or parent or guardian) gives written informed consent for publication. Informed consent for this purpose requires that the patient be shown the manuscript to be published.

Copyright: It is a condition of publication that authors assign copyright or license the publication rights in their articles, including abstracts, to Taylor & Francis. This enables us to ensure full copyright protection and to disseminate the article, and of course the Journal, to the widest possible readership in print and electronic formats as appropriate. Authors may, of course, use the article elsewhere *after* publication without prior permission from Taylor & Francis, provided that acknowledgement is given to the Journal as the original source of publication, and that Taylor & Francis is notified so that our records show that its use is properly authorised. SUBMISSION

Submit three good quality photocopies of all written material and illustrations, accompanied by a covering letter signed by all authors. Alternatively, submit via e-mail to acta.obstet.gynecol@obgyn.gu.se. Please note that case reports are not accepted in *Acta Obstetrica et Gynecologica Scandinavica*.

Please keep illustrations as separate files, e.g. EPS or TIFF. However, Taylor & Francis can handle various application formats. For details please go to www.tandf.no/actaobgyn

Manuscript layout: Manuscripts should be written in English and typed double-spaced including references, tables and figure legends, and leave generous margins. The pages should be consecutively numbered. Use the following subheadings; Abstract, Abbreviations, Material and Methods, Results, Discussion, Acknowledgements, References and Legends to figures. Preferably the text part of the manuscript should not exceed 2200 words.

Title page: The title page should carry: title of the article; name of each author and institutional affiliation; name and address of the corresponding author; a short running head of no more than 40 characters.

Abstract and Key words: The abstract to original articles should be structured with the following subheadings: Background Methods, Results and Conclusions. It should not exceed 250 words. Below the abstract authors should provide up to 5 key words.

References: The Vancouver system must be applied. Number the references consecutively in the order in which they are first mentioned in the text. Identify references in the text using Arabic numerals in parentheses. Papers accepted but not yet published should be designated as (in press). Information from papers in manuscript but not yet accepted should be cited in the text as 'unpublished observation(s)' or 'personal communication'. References cited only in tables or in legends to figures should be numbered in accordance with the sequence established by the first identification in the text of the particular table or figure. List all authors when 6 or fewer, when 7 or more, list the first six and add 'et al'.

Abbreviations of journal titles: please consult the *List of Journals Indexed in Index Medicus*, published annually as a list in the January issue of *Index Medicus*, also accessible at www.nlm.nih.gov

1. *Standard journal article*
– List all authors when six or less. When seven or more, list only first six and add *et al*.
Example:
Soter NA, Wassermann SJ, Austen KF. Cold urticaria. *N Engl J Med*. 1975;294:687–9.
If the language is not English, add the translated title in brackets, e.g. Swedin G. Transkutan elektrisk nervstimulering som smärtlindring vid förlossning. [Transcutaneous electrical nerve stimulation for analgesia in childbirth.] (in Swedish with English abstract.) *Läkartidningen*. 1979;76:1946–8.
2. *Book*
Eisen HN. Immunology: an introduction to molecular and cellular principles of immune response. 5th Edn. New York: Harper and Row, 1974:406.
3. *Chapter in book*
Weinstein L, Swartz MN. Pathogenic properties of invading microorganisms. In: Soderman WA Jr, Soderman WA, editors. Pathologic physiology: mechanisms of disease. Philadelphia: WB Saunders; 1974. p. 457–72.

Tables and figures: The number of tables and figures should be minimized. There should be no repetition/overlap of information given in tables/figures/text respectively. For further information please see www.tandf.no/actaobgyn

Graphic elements should be kept as separate files in EPS-, PDF- or TIFF-format. These formats guarantee that the quality of the graphics is good throughout the publishing process if provided with sufficient resolution. Photo illustrations should have at least 300 DPI and please use CMYK colour conversion. Costs for colour illustrations must be borne by the authors.

Halftones and colour photos should be enclosed separately. If you want to print in black and white, please provide black and white originals, if possible. Glossy photocopies or good quality hard copies are preferred rather than low resolution electronic files.
