INFORMATION FOR CONTRIBUTORS

Refereed Papers

Papers should be in the range of 6,000–7,000 words (including abstract, references, endnotes and space taken for tables/figures – calculated on 600 words to a journal page) in length, typed in 12-point font on A4 paper, paginated and double-spaced. The title should be on page 1 and not exceed 10 words (50 letters), and should be followed by an abstract of 100–200 words.

A separate first page should include the full title, author name(s), institutional and email address(es), and indicate the author responsible for correspondence related to manuscript submission. The full postal address of the author who will check proofs and receive correspondence and offprints should also be included.

Reviews

Reviews can vary from 1,000 words for a single-title review to 6,000 words for an essay review. Contributors should follow the guidelines for articles, and attempt to review books in terms of related and current literature and scholarly debate.
