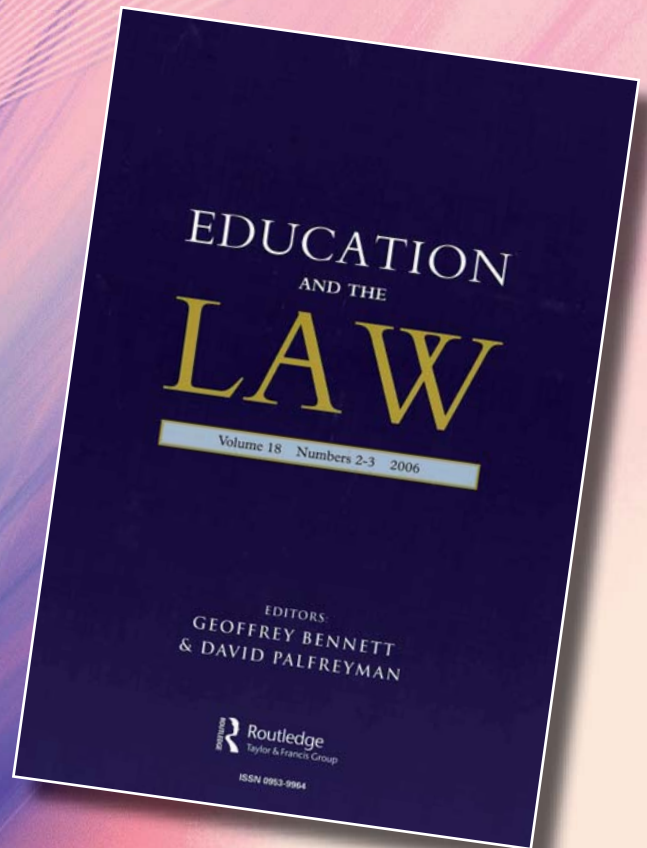

- EEC implications for education

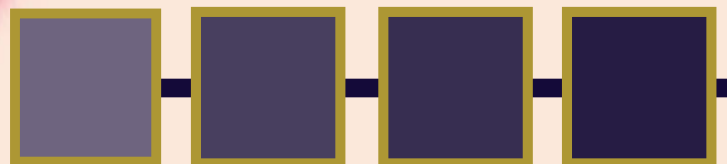

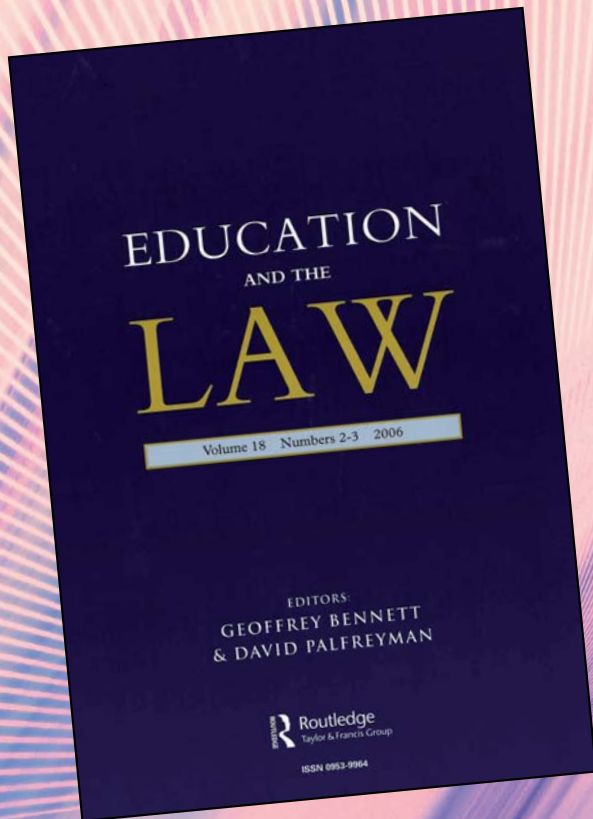
